**An Appeal Case U/S 19(3) of RTI Act, 2005**

**APPELLANT** : Shri Tamchi Gungte, near KV-IIChimpu Itanagar

**RESPONDENT** : The PIO, o/o the Executive Engineer (PWD), Mechuka Division, Shi Yomi District (A.P)

**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of 27(twenty seven) point information on the C/o "Cement Concrete Pavement road in Mechuka Township in Shi Yomi District (A.P) during the financial year of 2023-24 by the PIO, o/o the Executive Engineer (PWD), Mechuka Division, Shi Yomi District Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 14.10.2024.

This appeal was heard on 04.07.2025 wherein the PIO, Er. Shri Onit Borang, E.E was present in person with the documents but the appellant, Shri Tamchi Gungte did not appear but informed vide letter dt.04.07.2025 that due to some serious health issues he will not be able to attend the hearing.

The PIO complained that the appellant neither visited his office to collect the requested information nor attended the 3 (three) hearings fixed by the First Appellate. This Commission, after hearing the PIO and perusing the documents brought in by the PIO which were found not properly paged and indexed, returned the documents to the PIO and directed him to furnish them to the appellant with proper indexing and paging before the date of next hearing i.e today on 08.08.2025.

Today the appellant is present in person. The PIO is also present with the requested documents which has been handed over to the appellant who has been directed to go through the same and report his satisfaction or otherwise therewith to this Commission within 2(two) weeks for further consideration.
