## **SUMMONS**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of below mentioned information by the PIO, o/o the Executive Engineer (PWD), Mechuka Division, Shi Yomi District Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 11.11.2024

- A. Particular of information:c/o "the total list of project sanctioned under Pradhan Mantri Jan Vikas Karyakaram (PMJVK), erstwhile-MsDP Scheme, Ministry of Minority Affairs Govt. of India" during the financial year 2018-19.
  - i. Construction of 100 bedded Girls Hostel at Govt. Secondary School, Monigong in Mechuka Block of Shi Yomi District.
  - ii.Construction of 50 bedded Girls Hostel at Govt. Secondary School, Tato in Mechuka Block of Shi Yomi District.Details of information:

## **B.** Detailes of information:

- 1. The certified sanction order copy.
- The certified copy of Proof ( such as Voter ID and PRC) that the tender winning firm Domicile status within the Territorial Jurisdiction of that Constituency Assembly as per District Based Entrepreneur and Professionals (Incentive, Development and Promotion) Rules, 2015.

- 9. The certified copy of completion certificate of the project.
- 10. The certified copy of Newspaper in which NIT was published (At least 3 newspaper name (One National & 2 Local) along with date of publication of Newspaper, as per Govt. approved Order.

- 11. The certified Design and Scope of Work in the projects.
- 12. The certified copy of Work Specification of the projects.
- 13. The certified copy of the documents submitted by tender participant for Technical Bid.
- 14. The name of Firms who won the tender work with respect to the subject mentioned above.
- 15. The name of officers and their Designation at the time of monitoring work.
- 16. The certified copy of Contractor Registration, of tender participant and winning firm.
- 17. The certified copy of Contractor Enlistment Update reports (Civil/ Composite Category as per the nature of work), of tender participant and winning firm.
- 18. The certified copy of EMD and Security money deposited by all the tender participant.
- 19. The certified Integrity Pact submitted by the tender participant.
- 20. The certified Affidavit copy Sworn before a Competent Magistrate to the effect that he/she (tender participant), does not have 2 (two) or more incomplete ongoing commitment (projects /contract to execute) at the time of bidding by the tender participant and winning firm. (as per rule SPWD/W-66/2012 as per District Based Entrepreneurship Act, 2015).
- 21. The certified documents submitted by tender participant and winning firm, i.e copy of completed three similar work each of value not less than 40% of the estimate cost or completed two similar work each of value not less than 60% of the estimate cost or completed one similar work of value not less than 80% of the estimated in the last 5 years ending last day of the month previous to the one in which the tenders are invited.
- 22. The Certified copy of Acceptance letter for tender work by the Executing Agency to the tender winning firm.
- 23. The certified copy of work order given to the contractor by the Executing Department.
- 24. The Agreement copy made between the contractor and the Executive Agency for the projects mentioned above.
- 25. Certified copy of all photograph of work item (Glossy paper) before starting of work and photograph (Glossy paper) after completion of work.
- 26. The Geo Coordinate information for the work mentioned above.
- 27. The certified Payment details(Cheque no., voucher, PFMS etc. (While ever method is used of payment) of the project till date.

Records in the appeal reveal that the appellant had requested the PIO for the aforementioned information but failed to obtain the same within the statutory period of one moth which prompted him to file appeal before the First Appellate Authority (FAA), the CE (PWD), Central Zone – B, Pasighat, East Siang District, Govt. of A.P. under section 19(1) of the RTI Act vide his Memo of Appeal dt. 17.01.25.

Records also reveal that the FAA attempted to conduct the hearing on 22.01.2025 and issued summon notice dt.03.01.2025. There is, however, no further records as to the actual hearing of the appeal by the FAA.

Be that as it may, the 2<sup>nd</sup> appeal having been preferred by the appellant vide his Appeal Memo dt.17.03.2025, the appeal has been registered in this Commission and listed for hearing today on 04.07.2025.

The PIO, Er. Shri Onit Borang is present in person but the appellant, Shri Tamchi Gungte is absent who informed vide his letter dt.04.07.2025 that due to serious health issue he will not be able to attend the hearing.

The PIO submitted that he has no knowledge of this particular appeal and therefore, he will not be able to make any submission in this appeal and hence requested for a copy of the RTI application filed by the appellant. As requested, a copy of the RTI application dt. 11.11.2024 filed by the appellant before the PIO has been provided to the PIO and adjourned the hearing of this appeal to 08.08.2025 with direction to him to provide the requested documents to the appellant as per his RTI application and report compliance on or before 08.08.2025.

This appeal is, thus, listed again on 08.08.2025.
