## ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Nabam Tapak, Lekhi Village, Near Iconic Dealer, PO/PS Nirjuli, Papum Pare District, Arunachal Pradesh for non-furnishing of information by the PIO -cum-DDSE, Govt. of A.P., Ziro, Lower Subansiri District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 07/03/2022 regarding the details of appointment orders of PTI & PTI Grade-II, PTT, PET, PRT, TGT.
- 2). The 18th hearing was held on 3rd June, 2025. Shri Kocho Jomoh, the PIO -cum-DDSE, Govt. of A.P., Ziro, Lower Subansiri District, Arunachal Pradesh was represented by Shri Taba Guch, APIOcum-B.E.O. The Appellant Shri Nabam Tapak appeared before the court after the hearing of the case.
- 3). The APIO had brought remaining information to be furnished to the Appellant in the court room during the hearing. The Appellant was not present during the hearing, so the APIO could not hand over the information to the Appellant.
- 4). The Commission directed the APIO to contact the Appellant and handover the information.
- 5). The Appellant appeared before the Commission after the hearing and submitted that he has been furnished with remaining information by the APIO and appealed the Commission to give time to go through the information.
- 6). The Commission giving reasonable opportunity directed the Appellant to go through the information and intimate the Commission within one week from the date of issue of this order, failing which the case would be disposed of.
