### ORDER

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Ms Bengia Mama, Jollang, Near Himalayan University, Itanagar, PO /PS Itanagar, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum- DLRSO, Capital Complex, Itanagar, Papum Pare District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 13/06/2025 regarding detail of information of Mandal, RK, & SK.

2). The 1<sup>st</sup> hearing was held on 25<sup>th</sup> November' 2025. Ms Byabang Naemeh, PIO-cum- DLRSO, Capital Complex, Itanagar, Papum Pare District, Arunachal Pradesh and the Appellant Ms Bengia Mama were present.

3). The Commission had directed the PIO to write a to the Land Management Department under intimation to the Commission and also furnish a copy to the Appellant.

4). The Commission had directed the authority of the Land Management Department to furnish information to the DLRSO Capital Complex or directly to the Appellant within fifteen days from the date of issue of the order dated 25<sup>th</sup> November'2025.

5). The Commission had asked the Appellant to intimate her satisfaction or dissatisfaction after receipt of information.

6). The Appellant vide letter dated 24<sup>th</sup> December'2025 submitted that the PIO and the authority of Land Management Department failed to furnish information as directed by the Commission and appealed the Commission for continuation of hearing.

7). The Commission to hear from the both the parties decided to fix a date of hearing.

8). The next date of hearing is fixed on 3<sup>rd</sup> March'2026 (Tuesday) at 1100hrs.

9).Therefore, the PIO-cum- DLRSO, Capital Complex, Itanagar, Papum Pare District, Arunachal Pradesh, is hereby summoned to appear before this Court in person or through Video Conferencing on the scheduled date and time without fail.

10). Take notice that in case of default in appearing on the day of hearing mentioned above, the appeal will be heard and determined ex-parte and penalty under section 20(1) of the RTI Act, 2005 shall be invoked against the PIO. In case the Appellant remains absent the case would be disposed of.
