ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Riya Taram, Shri Bengia Tahar & Shri Lokam Namdu, for non-furnishing of below mentioned information by the PIO, o/o the E.E (PWD), Roing Division, Lower Dibang Valley District (A.P) as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 28.12.2024

A) Particular of information: To furnish all the relevant information against name of Scheme/ Work list under funding head of BE/RE 2016-24.

B) Details of information required:

- 1. Name of Scheme/Work list/DPR Copy/Coloring Photocopy Geo-tag Report of every work site.
- 2. Copy of work order/sanction order copy with annexure details moods of contractor/firm payment like Cheque leaf/demand draft/banker cheque/RTGS slip by Department as per the Name Scheme/work list wise.
- 3. Money Receipt of Contractor/firm Payment list as according to the name of Scheme/Work list wise with their Signature and contact number.
- 4. Xerox copy of Firm/Enterprise Trading Licence.
- 5. First & final bill copy of all the works with enclose details of payment like Cheque leaf/demand draft/banker cheque/RTGS slip of contractor/firm by department as per the Name of Scheme/work list wise.
- 6. Billing detail sheet/scheme detail Sheets copy of work wise.
- 7. Xerox copy of Cheque leaf/Banker Cheque/RTGS/billing Challan/voucher of Contractor/firm bill payment by department as per the Name of Scheme/work list/work order wise.
- 8. Measurement/Cashbook Statement in work wise.
- 9. Payment List of Contractor/firm/Hand receipt with payees name.
- 10. Various name of deduction amount from contractor/firm bill payment as percentage as per Govt. guidelines.
- 11. Certified Coloring Photocopy of all the Work Sites by Concern PIO.
- 12. Coloring photocopy/videography of every work site which may be Before starting of work/Starting of work and Ending of work.
- 13. NOC copy of ZPC/ZPM/GPC/Gaon buras / buris of concern Segment/block.
- 14. Name of Officers & Officials with their Signature/Seal, Who hold the DDO Power to approved the financial matter or handled the Works.

- 15. Details of Enlistment of contractor as per work department Rules Act 2008.
- 16. Details of proprietor of firm/Registration of certificate.
- 17. Money deposited Challan of the Govt. account against GST/Royalty by department/Firm/Enterprise.

Brief facts and decision:

Records emerging from the appeal disclose that the appellants, Shri Riya Taram, Shri Bengia Tahar & Shri Lokam Namdu had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted them to filed appeal before the Chief Engineer, PWD, Govt. of A.P, Eastern Zone, Namsai, the First Appellate Auhority under Section 19 (1) of RTI Act, 2005 vide Memo of Appeal dt. 14.02.2025. However, the appellants having failed yet again to obtain the information preferred 2nd appeal before this Commission under Section 19 (3) of the RTI Act, 2005 vide Memo of Appeal dt. 21.03.2025.

This appeal is accordingly, listed today on 1st August, 2025.

The appellants are absent but on thier behalf, one Shri Chow Lajamang Mannow represented them while the PIO is represented by Shri Vikash Bagang, J.E who has brought in the requested documents.

The documents brought in by the representative of the PIO have been handed over to the representative of the appellants who are directed to intimate this Commission of their satisfaction or other wise therewith within 1(one) week from today for further consideration of the appeal failing which this appeal shall stand disposed of and closed presuming that they are satisfied with the information.
