Information sought:

The appellant filed an RTI application dated 19.02.2025 seeking all the relevant information against C/o "Construction and erection of Poles and Towers of 132 KV (S/C (on D/C Tower)) from Subansiri right bank (NHPC Gerukamukh) to Nari Village Lower Siang District, Arunachal Pradesh" under Power Grid Corporation of India Limited (PGCIL) During the financial year 2019-24.

Particulars of sought information are given below: -

1. Furnish the CTC copy and the Details of the Total Sanction amount by the Power Grid Corporation of India Limited (PGCL) for the payment of Compensation to the affected land owner.
2. Furnish the CTC copy of DPR of the subject mentioned above.
3. Furnish the CTC copy of Total nos. of approved poles/Towers as per the DPR Prepared by the PGCIL.

4. Furnish the CTC copy of Proper Guidelines approved by central and State Government to compensate the affected Land owner.
5. Furnish the CTC copy of the name and Total list of the affected Land owner who availed Compensation along with the amount received by the each and every affected land Owner, from the PGCIL for the project mentioned above.
6. Furnish the CTC copy and details of DBT done to all the affected Land Owners account.
7. Furnish the CTC copy of Under Taking Signed by Affected Land Owner while receiving the Compensation amount.
8. Furnish the CTC copy of the Details Survey Report and Estimate prepared for Compensation against each Affected Land Owner.
9. Furnish the CTC copy of Rate fixed and approved by the Govt. of India for the Land, the Standing Structures (House, Fencing, water Tank etc.) and all the Agriculture and Horticulture Plantation items.
10. Furnish the CTC copy of Geo-tagging map of the area where the Tower/Pole to be constructed.
11. Furnish the CTC copy of Payment made to the Affected Land Owner till date.

Relevant facts emerged during hearing:

Previous Hearing:

First : 29.08.2025

Order of the 1st hearing- *"The Commission observes that the appellant has failed to get a response from the FAA within the stipulated period. The Registry of the commission has referred back the appeal case vide letter dated 06.06.2025 to the FAA – Deputy Commissioner, Lower Siang District with direction to adjudicate the First Appeal by ensuring that both parties are given a fair opportunity to be heard and dispose of within 30 days. The FAA has not complied with the direction of the Registry within stipulated time."*

The following were present.

Appellant : Absent.

Respondent PIO : Present. He has submitted that he has already furnished sought information to the appellant by post. He has produced proof copy of receipt record of the post office. He also brought with him the Xerox copy of information furnished to the appellant during the hearing and requested the appellant to collect the information from his office (DLRSO) Likabali in case he has not received the information.

F A A : Present through VC.

Decision:

The Commission after adverting to the facts and circumstances of the case, hearing the PIO and perusal of the records, observes that the appellant has not complied with the order dated 29.08.2025.

The appellant is directed to confirm the receipt of the information and file a written submission to PIO stating specific shortcomings, if any, under intimation to this commission on or before 27.10.2025. In case no written submission is received from the appellant within the stipulated time this appeal case shall remain stand closed.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant.

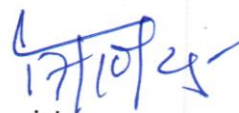
