Information sought:

The appellant filed an RTI application dated 03.10.2024 seeking following information regarding C/o "Integrated infrastructure Development for Tourism at Tawang with the provision of sewage and water treatment plant at Tawang District, under the North East Special Infrastructure Development Scheme (NESIDS) in Arunachal Pradesh during the financial year 2020-21.

Particulars of sought information:

- 1. Furnish the Certified copy of Integrity Pact submitted by the tender participant.
- 2. Furnish the certified copy of Work Specification of the project.
- 3. Furnish the certified copy of Design and Scope of the project.
- 4. Furnish the certified copy of EMD and Security money deposited by all the tender participant.
- 5. Furnish the certified copy of Completed three similar work each of value not less than 40% of the estimate cost or completed two similar work each of value not less than 60% of the estimated cost or completed one similar work of value not less than 80% of the estimated

- cost in the last 5 years ending last day of the month previous to the one in which the tender is invited.
- 6. Furnish the certified copy of Documents submitted by the tender participants for Technical Bid in the tender process.
