**ORDER**

1). This is a complaint under Section 18(1) of RTI Act, 2005 filed by Shri Tania June, E-Sector Naharlagun, Po/Ps Naharlagun, Arunachal Pradesh, for non-furnishing of information by Shri Joram Uku, PIO-cum-EE(PWD), Govt. of A.P., Public Works Department, Dirang Division, West Kameng District, Arunachal Pradesh, as sought by the complainant under Section 6(1) of RTI Act, 2005 vide Form-A Dated 12/09/2024 regarding details of staff engaged under Group B/Group C/ WCT R / UDC / LDC / PEON / Driver / Contingency / all MTS Post etc.

2). The 1<sup>st</sup> hearing was held on 18<sup>th</sup> November, 2025 as scheduled. Shri Joram Uku, PIO-cum-EE(PWD), Govt. of A.P., Public Works Department, Dirang Division, West Kameng District, Arunachal Pradesh was absent. The Complainant Shri Tania June was represented by Shri Donik Roru.

3). The representative of the Complainant informed that the PIO had not furnished any information till date.

4). The Commission viewed the absence of the PIO, without any justifiable reason, seriously.

5). The Commission hereby directs Shri Joram Uku, PIO-cum-EE(PWD), Govt. of A.P., Public Works Department, Dirang Division, West Kameng District, Arunachal Pradesh to **SHOW CAUSE** as to why Penalty should not be imposed on him under section 20 (1) of the RTI Act, 2005.

6). Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the PIO is found absent the Commission will initiate penal action under section 20(1) of the RTI Act, 2005, and issue Arrest Warrant under section 18 (3)(a) of the RTI Act, 2005 to compel attendance. In case Complainant is found absent the case shall be disposed of without any further notice.

6). The next date of hearing is fixed on 20<sup>th</sup> January 2025 (Tuesday) at 1100hrs.
