ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Ms Bengai Mama, Dariya Hill Colony, near Donyi Polo Road, Itanagar, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE (RWD), Daporijo Division, Upper Subansiri District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 24/03/2025 regarding **construction of Suspension Bridge over Kojen river in between Rigia to Duchok in Upper Subansiri District, Arunachal Pradesh.**
- 2). **The 1st hearing was held on 10th February' 2026 (Tuesday) at 1100 hrs. Both the parties were absent.**
- 3). The Appellant Miss Bengia Mama, Dariya Hill Colony, Itanagar had submitted a letter Vide No. Nil dated 6th February' 2026 requesting the Commission for postponement of today's Court hearing and re-scheduled in the month of March 2026 as she had very important engagement during this period.
- 4). Based on the request of the Appellant, the Commission rescheduled the next date of Court hearing.
- 5). **The next date of hearing is fixed on 17th March'2026 (Tuesday) at 1100hrs.**
- 6). The PIO was found absent today without any representation on his behalf. Therefore, the PIO is directed to appear in person in the next date of hearing. Failure to comply with the directions would invite action as per the provisions of RTI Act, 2005.

6). Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the PIO is found absent the Commission will initiate penal action as per provisions of the RTI Act-2005, and under subsection (2) of Section (20) of the RTI Act, would recommend disciplinary action under the service rule as applicable. In case Appellant is found absent the case shall be disposed of without any further notice.
