## ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Adv. Teli Ango, & Mr. Nagbia Kyokam, C/o Gauhati High Court Itanagar Permanent Bench, Yupia Naharlagun, PO/PS Naharlagun, District Papum Pare, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE(RWD), Govt. of A.P., Department of RWD, Sagalee Division, Toru Circle, Papum Pare District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 18/11/2024 regarding PMGSY Road from Ompuli to Tamang Village, Toru Circle under Sagalee ST. Constituency District Papum Pare (A.P).
- 2). The 3<sup>rd</sup> hearing was held on 14<sup>th</sup> October 2025. The PIO-cum-EE (RWD), Govt. of A.P., Department of RWD, Sagalee Division, Toru Circle, Papum Pare District, Arunachal Pradesh was absent. The Appellant Adv. Teli Ango was present.
- 3). The Appellant submitted that he had not been furnished with any information by the PIO.
- 4). During the hearing, the Commission was informed through a phone call that Shri Gollo Tara, the previous PIO-cum-EE(RWD), Govt. of A.P., Department of RWD, Sagalee Division, Toru Circle, Papum Pare District, Arunachal Pradesh had demitted office on retirement and new incumbent Shri Techi Totu Tara, EE(RWD), Govt. of A.P., Department of RWD, Sagalee Division, was yet to join.

- 5). The Commission giving reasonable opportunity to the new incumbent, hereby decides to fix a date of hearing.
- 4). The next date of hearing is fixed on 25<sup>th</sup> November' 2025 (Tuesday) at 1100hrs
- 5). Therefore, Shri Techi Totu Tara, the PIO-cum-EE (RWD), Govt. of A.P., Department of RWD, Sagalee Division, Toru Circle, Papum Pare District, Arunachal Pradesh, is directed to appear in person or through Video Conferencing before the Commission's court, failing which the Commission shall be compelled to initiate penal action under section 20(1) of the RTI Act 2005 against the PIO. In case the Appellant is found absent the case would be disposed of.
