**ORDER**

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri John Tara Bakey, Yupia-II, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO, State Council for IT & E-Governance (Department of Information Technology and Communication), Itanagar, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 12/06/2024 regarding **appointment of Director, officers & staff.**

2). The 1<sup>st</sup> hearing was held on 5<sup>th</sup> August, 2025 (Tuesday) at 1100 hrs. Ms Namgey Wangmu, Deputy Director (IT)-Cum- PIO, State Council for IT & E-Governance (Department of Information Technology and Communication), Itanagar was present during the court hearing. The Appellant Shri John Tara Bakey was also present.

3) The Appellant stated that he had not received any information from the PIO as sought in form "A" regarding appointment of the Director, Officers & Staff till date and that he had also filed an appeal to the First Appellate Authority for hearing but no action was taken.

4) Ms Namgey Wangmu, Deputy Director (IT)-Cum- PIO, State Council for IT & E-Governance (Department of Information Technology and Communication), Itanagar stated that hearing notice letter was sent through postal services to the Appellant but the letter was returned for want of a proper address. It was re-sent through the postal services as also through whatsapp informing the Appellant that the documents were available in the office and that the Appellant could collect the information. But again the letter was returned while there was no response from the whatsapp too. The Appellant admitted that he has two addresses one at Yupia and another at Naharlagun and that the mobile no had incorrectly been recorded due to cyber staff putting wrong digit number.

6). After hearing both the parties the Commission observed that it was a matter of communication gap between them; however, directed the PIO to furnish all the available information to the Appellant. **The Appellant is hereby directed to collect the information (in Hard copy or Soft copy) from the PIO office within 15 days from the date of issue of this order and inform the Commission his satisfaction or dis-satisfaction.** If the Appellant does not comply with the direction, it will be presumed that the Appellant is no more interested in the information and the Appeal case would stand disposed of without further hearing.

7) **Based on the report of the Appellant further course of action for next hearing will be decided.**
