**SHOW CAUSE NOTICE**

(Form-4 CPC R/W Sec-20 (1) & (2) of the RTI Act, 2005.

To,

PIO-Cum-Director Social Justice, Empowerment and Tribal Affairs,  
Govt. of Arunachal Pradesh, Itanagar

**WHEREAS**, Sama Dongru Tania filled the Second Appeal against you before the Arunachal Pradesh Information Commission, Itanagar, **on 21.08.2023 U/S 19 (3) of RTI Act, 2005** vide Appeal No. **APIC-788/2023**, wherein, alleging against you that you failed to furnish information sought by the Appellant under Form-A of his application dated 12/06/2023 relating to the matter as quoted in Form-A application.

**WHEREAS**, you, being PIO-Cum- the Director of Social Justice, Empowerment and Tribal Affair, Govt. of Arunachal Pradesh have refused to furnish the information sought under RTI Act, 2005 to the appellant **within the prescribed period of 30 days from the date of receipt of his application as provided under Sub-Section (1) of Section-7 of the Act without any reason, whereby, amounting to violation of the said sub-section of section-7, liable for imposing reasonable penalty against you under the sub section (1) of section-20 of the Act.**

**WHEREAS**, date of hearing of the Appeals was intimated to you well in advance but you are found absent consecutively in two hearing on **22/01/24 and 11/03/2024** without intimation to the Commission. The Commission viewed seriously on the repeated absence of the PIO and showing reluctance attitude to appear in person before the Commission in every hearing, inspite of the directions of the Commission and **failed to furnish the information within prescribed period. So, you are found liable to impose reasonable penalty on your negligence for non-furnishing of the information as sought by the Appellant.**

**NOW THEREFORE**, you are hereby directed to appear in person before the Commission (APIC), Itanagar for hearing and to furnish the reply of Show-Cause Notice against you on or before **3<sup>rd</sup> June, 2024 at 1030 hrs** as to why you should not be imposed a reasonable penalty as provided in Sub-Section(1) Section-20 of the RTI Act for violation of **Sub Section (1) of the Section-7 of the RTI Act, 2005 and failing which, matter will be heard and determined in your absence.**
