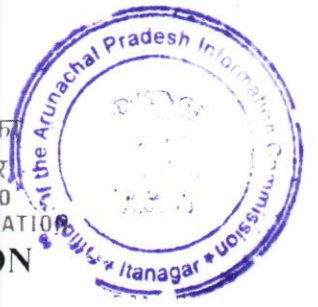

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Jacob Wangsu, Village Chattong, Chubam Circle, PO/PS Longding District, Arunachal Pradesh, for non-furnishing of information by the PIO -cum- EE(RWD), Longding Division, Longding District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 25/08/2025 regarding **up gradation of road from Channu '0' point to Chubam in Longding District, 20.00 lakhs.**

2). **The 1st hearing was held on 9th June' 2026**(Tuesday) at 1100 hrs. The Appellant Shri Jacob Wangsu was absent. Shri Techi Nibo, the PIO-Cum- EE (RWD), Longding Division, Longding attended the Court through online mode.
