JUDGMENT

This is a complaint filed under sub-section (1) of Section 18 of the RTI 2005. Brief fact of the case is that the Complainant, Shri Tania June on **19/01/2026** filed an RTI application in form 'A' before the PIO-cum-District Information & Public Relations Officer (DIPRO), West Siang District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in his Form 'A' application. The Complainant being not satisfied of the none admission of RTI application by the office of the PIO filed the First Complain before the First Appellate Authority (FAA) on **27/02/2026**. Complainant again having not received the required information from the FAA, filed the complaint before the Arunachal Pradesh Information Commission on **06/02/2026** and the Registry of the Commission (APIC) having receipt of the Complaint registered it as APIC- No. **03/C/2026** (Complaint) and processed the same for its hearing and disposal.
