Information sought :

The appellant file a RTI Application dated 30/06/2025 seeking Details regarding documents pertaining to Land Acquisition and Compensation Disbursed package-4 of Frontier High way Project from Lada to Sarli etc.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellants filed First Appeal dated 08/09/2025. The First Appellate Authority was conducted hearing in his jurisdiction on 16/09/2025. Feeling aggrieved and dissatisfied by the order of the FAA, appellant approached the Commission with instant Second Appeal.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Atum Pao & Ors on **30/09/2025** filed an RTI application under Form-'A' before the PIO-cum-DLRSO, Seppa, East Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed

the First Appeal before the First Appellate Authority on **08/09/2025**, Appellants, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **29/09/2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 739/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for three times i.e on 20/04/2026, 20/07/2026 and 07/09/2026. In this hearing of the appeal on **7th day of September, 2026**, both the parties PIO-cum-DLRSO, Seppa and the appellants Shri Atum Pao & Ors found absent without any intimation to the Commission.

Both the parties have been found absent for the last 3 consecutive times. The appellant was cautioned that if he is found absent in the next hearing, the case will be heard in his absence.

Today the appellant is absent for 3rd consecutive times without any intimation. The Commission presumes that the appellant is no more interested to pursue this appeal case and accordingly, the appeal case is disposed of and closed.
