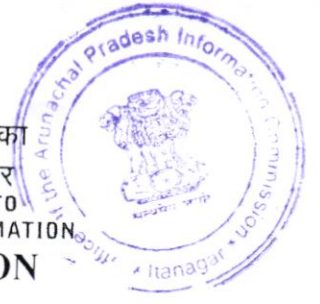

ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Chugma Sangbia, Niya Colony near CM Bunglow, PO/PS, Itanagar, Arunachal Pradesh, for non-furnishing of information by the Public Information Officer, (PIO), O/o Arunachal Pradesh Public Service Commission (APPSC), Itanagar, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 09/01/2026 regarding **Shri Tano Nima, Assistant Section Officer.**
- 2). **The 1st hearing was held on 9th June' 2026 (Tuesday) at 1100 hrs.** The Appellant Shri Chugma Sangbia and Shri Adong Pertin, the PIO- Cum- Jt. Secretary, APPSC, Itanagar were present in the Court.
- 3). The PIO stated that the information as sought by the Appellant had already been furnished to the Appellant Vide Memo No. PSC/RTI-100/2025 Dated Itanagar, the 3rd June' 2026. The Appellant however, denied receiving the information. The PIO handed over copy of the documents to the Appellant in presence of the Commission.
- 4). Consequently, the Appellant pleaded the Commission to dispose the case.
- 5). Based on the submission made by the Appellant, the Commission observes it fit to dispose of the case.

Therefore, the case is hereby disposed.
