Information sought :

The appellant file a RTI Application dated 04/09/2024 seeking Details regarding Appointment order of TGT & Primary Teachers and complete document of RR of Primary Teachers.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellants filed First Appeal dated 15/07/2025. No hearing has been conducted by the First Appellate Authority in his jurisdiction in this regard. Feeling aggrieved and dissatisfied by the order of the FAA, appellant approached the Commission with instant Second Appeal.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Taram Kenji, Nangram Ganesh, Gichik Topor Kiogi on **04/09/2024** filed an RTI application under Form-'A' before the PIO-cum-Dy. Director, Elementary Education, Papum Pare District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on

21/10/2024, Appellants, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 22/11/2024 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as APIC No. 357/2024 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for eight times i.e on 12/03/2025, 16/04/2025, 30/04/2025, 08/10/2025, 11/03/2026, 04/05/2026, 27/07/2026 and 09/09/2026. In this hearing of the appeal on 9th day of September, 2026, both the parties, appellants Shri Taram Kenji, Nangram Ganesh and Gichik Topor Kiogi and the PIO-cum-Dy. Director, Elementary Education found absent without any intimation.

However, the following PIO-cum-DDSE of the Districts are present in person/present through VC before the Commission today: (1) Kiyi Panyor, (2) East Siang District, (3) Shi-Yomi District, (4) West Siang District (5) Anjaw District, (6) Lower Subansiri District and East Kameng District.

As per the case record, it is seen that almost all the DDSE of the Districts have provided the information to the Director of Elementary Education or directly to the appellant through their postal address or brought information before the Commission to provide the information to the appellant. The appellant in this case are absent for the last 3 consecutive times without any intimation in spite of giving summoned notice through their postal services, through their personal whatsapp number and through the whatsapp group.

The appellants were well cautioned on the last hearing that if they are found absent, the appeal case will be decided in their absence and dispose of. Today the appellants are absent for 3rd consecutive times without any intimation.

Therefore, the Commission presumes that the appellants have received all the information and are no more interested to pursue this appeal case and accordingly, this appeal case is disposed of and closed in their absence.
