Information sought :

The appellant file a RTI Application dated 01/04/2026 seeking Details regarding relevant documents i.e., transfer order, administrative approval, Law vetting, advertisement etc. for the post of Assistant Professor (Gastroenterology) to other department.

As per the case record, PIO had furnished all the sought information.

Being dissatisfied, the appellants filed First Appeal dated 13/05/2026. First Appellate Authority had conducted hearing in his jurisdiction on 12/06/2026. Feeling aggrieved and dissatisfied by the order of the FAA, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Habung Ruja present.
Respondent : PIO-cum-Director, TRIHMS is represented by Shri Tumgo Ete, Accountant.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Habung Ruja on **01/04/2026** filed an RTI application under Form-'A' before the PIO-cum-Director, TRIHMS, Naharlagun, Papum Pare District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A

application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **13/05/2026**, Appellants, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **26/06/2026** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 465/A/2026** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for one time i.e on **27/07/2026**. In this hearing of the appeal on **27th day of July, 2026**, the PIO-cum-Director, TRIHMS is represented by Shri Tumgo Ete, Accountant, and the appellants Shri Habung Ruja present in person.

As per the case record, it is seen that the PIO-cum-Director, TRIHMS has given his reply as per the Form 'A' application. PIO stated that he has given the reply as per Form 'A'. The appellant requested to give Para-wise reply to his queries as per the form 'A' application. PIO stated that he has given Point-wise reply to all the queries and he has nothing more to give.

The Commission has no authority to direct the PIO to give information which he has already replied as per form 'A', the Commission can only direct to provide the information which is available with the authority.

Therefore, the reply given by the PIO shows that whatever documents are available have been provided, so there is no point to continue this appeal case and the appeal case is accordingly disposed of and closed.

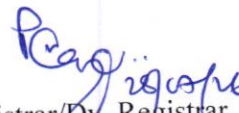
