Information sought:

The appellant has filed an RTI application dated 21.02.2026 seeking following relevant information in respect to Shri Nangram Pikap, ADC Koloriang-District Kurung Kumey for holding dual charge in the district.

1. Furnish the copy of order of dual charge as PD (Project Director) by Shri Nangram Pikap, District Kurung Kumey-Koloriang.
2. Furnish the copy of order of dual charge as DTCO (District Trade & commerce Officer), District Kurung Kumey-Koloriang.
3. Furnish the copy of order of dual charge as District Panchayat Development Officer (DPDO), District Kurung Kumey-Koloriang.
4. Furnish the copy of order of dual charge as District Transport Officer (DTO), District Kurung Kumey-Koloriang
5. Furnish the copy of order of dual charge as member Secretary of Koloriang CD Block upper & Lower Koloriang, District Kurung Kumey.
- b). All the documents must be provided in CTC by the concerned PIO.

(ii) Period from which Information asked for: - 2024 -2026.

The following were present.

Appellant

: Present. He states that the PIO has not furnished any information to him.

Respondent PIO

: Absent. Mrs Nido Ronnie (CO) represented the PIO. She states that available information/documents already been furnished by registered post. Today she sent information/documents through WhatsApp to this court. Th print copy of the information has been furnished to the appellant.

On interjection the appellant has agreed to have received the information document from the PIO and requested for closure of this appeal case.

Decision:

The commission after adverting to the facts and circumstances of the case, perusal of the records and hearing the parties, observes that the FAA – Deputy Commissioner, Koloriang has heard the appeal case on 05.05.2026 with a direction to the PIO to furnish the requested information within 7 days, with liberty to the appellant to prefer a second appeal under section 19 (3) if he is aggrieved/dissatisfied with the information furnished.

Since, the PIO has furnished the sought information to the appellant. The appellant has agreed to close his appeal case. Therefore, this appeal case is fit to be close.

The appeal case is disposed of accordingly at this commission.
