ORDER

- 1). The 3rd re-scheduled hearing was held on 21st July' 2026 (Tuesday) at 1100 hrs. Shri Taba Torum, PIO-cum-DLRSO, Govt. of A.P. Changlang HQ, District Changlang, Arunachal Pradesh and the Appellant Shri Sengman Ronrang appeared before the Commission's court through online mode of hearing.
- 2). The PIO informed the Commission that he had replied the Show Cause Notice Memo No. C/LR/RTI24-25/56-58 dated 6th May' 2026, wherein he explained that due to an oversight and pressure of the work he missed the date of hearing inadvertently. However, he confirmed having compiled the requisite information as sought by the Appellants in compliance with the courts order.
- 3). The Appellant Shri Sengman Ronrang stated that he had not received information from the PIO as on date.
- 4) The Appellant also requested the Commission to consider compensation for accommodation expenses while attending court cases, but the Commission turned down his plea for compensation.
- 5). The PIO informed that he had already furnished the list of 471 land affected beneficiaries to the Appellant through the Postal Service's No. C/LR/RTI/245/89 on 2nd March'26 and e-mailed to the Deputy Registrar, APIC, Itanagar on 6th May' 2026.
- 6). The Commission directed the Appellant to go to the Post office to check and get the information sent by the PIO. At the same time, directed the PIO to provide a copy of information immediately after the conclusion of the hearing.

7). The Commission further apprised the Appellant about the strategic nature of this project, Arunachal being a frontier state, and informed that such strategic projects are exempted from public scrutiny due to security concerns. Since the list of beneficiaries has already been provided to the Appellant, the Commission finds it appropriate to close the case. **The case is hereby disposed of.**
