An Appeal Case U/S 19(3) of RTI Act, 2005

Case No. APIC- 242/2026.

APPELLANT : Shri Ha Tago, Shri S.Tallu and Shri Taghu Noa, Hakun Village, Nirjuli.
RESPONDENT : (1) The Block Development Officer, Pipsorang CDBlock, Kra Daadi.
(2)The Block Development Officer, Chambang CD Block, Kra Daadi

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from ShriHa Tago, Shri S Tallu and Shri Taghu Noa for non-furnishing of below mentioned information by the PIO, o/o Dy. Director RD Kra Daadi District as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 10.10.2025.

A. Particular of information: details information about the particular scheme under PMKSY 2.0 against all mentioned below Blocks namely:

- 1. Tali Block. 2. Pipsorang Block. 3. Chambang Block. 4. Gangte Block. 5. Palin Block. 6. Yangte Block.**

B. Details of information required:

1. Furnish a CTC copy of Sanction order & Technical sanction order of each project
 2. Furnish a CTC copy of total amount allocated under PMKSY Scheme against the all Mentioned above blocks
 3. Furnish a copy of NIT published by any local newspaper against all mentioned above scheme
 4. Furnish a copy of firm & tender participants list
 5. Furnish a copy of successful Firm contractors list
 6. Furnish a copy of agreement made between firm contractors and work agency department
 7. Furnish a copy of Geo-Tagging and photographs of before and after work of each project
 8. Furnish a copy of MB Record against the each project
 9. Furnish a copy of utility certificate (UC) of each project
 10. Furnish a copy of Government guidelines for the mode of work implantation
 11. Furnish a copy of cheque amount and billing voucher dispatched to firm contractors /Beneficiaries
 12. Furnish a copy of NOC from HGB's or others against the projects for further release of Payment to Firm contractors
 13. Furnish a copy of U.O (Unofficial Note) to all mentioned above scheme project
 14. Furnish copy of mode of payment along with the counterfoils of payment made till date Against the aforesaid scheme project
 15. Furnish a copy of cheques amount dispatched to actual scheme beneficiary through cheque/PFMS/DBT etc.
 16. Furnish a copy of unused balance amount & solitum amount
- C. Period for which information asked for: 2021-2025.**

Brief facts emerging from the appeal and decision thereon :

Records emerging from the appeal disclose that the appellants, Shri Ha Tago and 2 others requested the PIO for the aforementioned information / documents but failed to obtain the same. Records in the appeal, however, disclose that the Block Development Officers (BDO), CD Block Pipsorang and CD Block Chambang, vide letter dt.24.11.2025 and dt. 03.11.25 respectively (as reproduced hereunder), had replied to the appellants that the works under the projects in question are ongoing and that the information thereof may be provided after the works are officially complete and over.

"Apropos to the subject cited above, I would like to apprise you that your RTI application regarding the implementation of WDC-PMKSY 2.0 is rescinded as it falls under section 8 (1) (d) of the RTI Act'2025. Also, the works under the said project is ongoing, till date. As such the information in this effect may be provided after the works are officially complete and over.

The appellants, apparently, disappointed with the response from the PIO -cum-BDOs as above, filed their 1st appeal before the Deputy Commissioner, Kra Daadi District, the First Appellate Authority (FAA) under Section 19(1) of the RTI Act, 2005 vide Memo of appeal dt. 06.01.2026. The records, however, did not indicate hearing by the FAA, but the appellants have preferred 2nd appeal before this Commission under Section 19 (3) of the RTI Act, 2005 vide Memo of Appeal dt. 24.02.2026 on the ground that despite hearing by the FAA, the concerned PIO did not furnish the replies.

This appeal was, accordingly, listed on 03.06.2026 wherein Shri Nangbia Taya, the Deputy Director, RD as the PIO and one of the Appellants, namely, Shri Ha Tago were present in person.

The appellant, reiterating his demand for the requested information, pleaded for an appropriate direction to the PIO to furnish the sought for information / documents.

The Dy. Director, RD, on the other hand submitted that his office is in no way concerned with the execution of the schemes in question, however, that on receipt of the RTI application from the appellants he requested the Block Development Officers (BDOs) concerned to furnish the sought for information to the appellant in response whereof the BDO, Pipsorang and BDO, Chambang, vide letters dt.24.11.25 and 03.11.25 respectively, addressed to the appellant, had informed that the information sought regarding the implementation of the scheme, WDC-PMKSY 2.0 falls under section-8(1)(d) of the RTI Act, 2005 besides the project being an ongoing project. The Deputy Director (RD), hence, pleaded that instead of his office, the offices of the concerned BDOs be directed to furnish the requested information. The DD(RD) also stated that except the said two CD Blocks, no other CD Blocks in the Kra Daadi District have executed the scheme in question.

This Commission, upon consideration of the submission of the DD(RD) and on perusal of the two letters from the two offices of BDO (supra), deemed it appropriate to appoint the BDOs of the said two CD Blocks, Pipsorang CD Block and Chambang CD Block as the PIOs of the respective Blocks so that the requested information/documents could be directed to be furnished to the appellants. Accordingly, vide order dt.03.06.26, this Commission, in terms of the provisions of section 19(8)(a)(ii) of the RTI Act, 2005, directed the Deputy Commissioner, Kra Daadi District to appoint the BDO, Pipsorang CD Block and the BDO, Chambang CD Block as the Public Information officers of their respective offices within 2(two) weeks from the date of receipt of this Commission's order dt.03.06.26 to secure and ensure compliance with the provisions of the RTI Act, 2005.

In compliance with this Commission's aforesaid order, the Learned D.C, Kra Daadi District, vide order dt.18.06.2026 (as extracted below), was pleased to appoint the Block Development officers (BDOs) of Chambang and Pipsorang CD Blocks as the Public Information Officers (PIOs) for their respective CD- Blocks.

// ORDER //

In pursuance of the Order passed by the Hon'ble Court of Arunachal Pradesh Information Commissioner, Itanagar vide No.APIC-242/2026/871 Dated 8th June 2026 and in exercise of the power conferred under the right to information Act 2005, the Block Development officer (BDOs) of Chambang and Pipsorang are to appoint as a Public Information Officers (PIOs) for their respective CD- Blocks to furnished the information of Centrally/State sponsored Schemes to appellants but it is seen that rest of the BDOs under Kra Daadi District are also implementing the centrally and State sponsored schemes/Projects.

Therefore, by seeing the practical issues in the ground the Block Development Officer CD-Block, Yangte, Gangte, Palin and Tali are also appointed and designated as Public Information Officers (PIOs) of respective CD-Blocks including BDO Chambang and Pipsorang with immediate effect until further order.

The Designated PIOs shall be responsible for receiving and furnishing of information under the provision of the RTI Act 2005 pertaining to their respective Block and shall ensure timely disposal of information in accordance with the Act and Rules framed thereunder.

This Commission noticed, with appreciation, that the Ld. Deputy Commissioner, by the same order, was also pleased to appoint the BDOs of rest of the CD Blocks, such as Yangte, Gangte, Palin and Tali as the PIOs of their respective Blocks which will go a long way in implementing the provisions of the RTI Act more smoothly.

In pursuance of the appointment of the BDOs of Pipsorang and Chambang CD Blocks as the PIOs of respective Blocks, this Commission directed the said BDOs-cum-PIOs to furnish the requested information /replies to the queries against the scheme/project in question falling under their respective jurisdiction to the appellant in right earnest and report the compliance thereof to this Commission on the next date of hearing on 29.07.2026.

This Commission has, in the meantime, received letter dt. 28.07.26 from the appellants (as reproduced hereunder) intimating that the PIOs of Chambang CD Block and Pipsorang CD Block have since furnished the requested information to them and therefore their pending appeal be closed.
