Information sought :

The appellant file a RTI Application dated 28/07/2025 seeking Details regarding to furnish all the relevant documents of the tender.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 10/09/2025. No hearing was conducted by the First Appellate Authority in his jurisdiction. Feeling aggrieved and dissatisfied by the order of the FAA, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Bengia Papo absent
Respondent : PIO-cum- Dy. Director of School Education, Koloriang absent.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Bengia Papo on **28.07.2025** filed an RTI application under Form-'A' before the PIO-cum-Dy. Director of School Education, Koloriang, Kurung

Kumey, District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellants, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **10.09.2025**, Appellants, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **15.10.2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 781/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for two times i.e on 20/04/2026 and 20/07/2026. In this hearing of the appeal on **20th day of July, 2026**, PIO-cum-Dy. Director of School Education, Koloriang and the appellants Shri Bengia Papo found absent without any intimation.

As per the case record on the hearing dated 20/4/2026, the appellant was cautioned that if he is found absent in the next hearing his case will be heard in his absence. It is also seen that there is no order of the First Appellate Authority, the Commission presumes that the appellant is no more interested to pursue this appeal case.

Therefore, the appeal case No. APIC-781/A/2025 is disposed of and closed.
