JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellant, Shri Tamchi Gungte on **30/01/2025** filed an RTI application in form 'A' before the PIO-cum-Executive Engineer (EE), RWD, Namsai Division, Namsai District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' application. The Appellant being not receiving the information from the PIO filed the First Appeal before the First Appellate Authority (FAA) on **20/03/2025**. Appellant again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **28/04/2025** and the Registry of the Commission (APIC) having receipt of the Appeal registered it as **APIC- No. 354/A/2025** (Appeal) and processed the same for its hearing and disposal..

Accordingly, matter came up for hearing before the Commission on 06.11.2025, 19.03.2026 & 04.06.2026.

Details of Information sought from the PIO;

1. Furnish the certified Sanction Order Copy.
2. Furnish the certified copy of Proof (such as Voter ID and PRC) that the tender winning firm Domicile status within the Territorial jurisdiction of that Assembly Constituency as per District Based Entrepreneur and Professionals (Incentive, Development and Promotion) rules, 2015 & 2020.
3. Furnish the certified PRC (Permanent Residence Certificate) submitted by tender Participant issued by the Competent Authority regarding domicile status within the District as per Rule 4(ii)(b) of the Arunachal Pradesh District Based Entrepreneurs and Professionals (Incentive, Development and Promotion) rules, 2015 & 2020.
4. Furnish the Name of Firms who won the Tender work with respect to the subject mentioned above.
5. Furnish the Name of Officers and their Designation at the Time of monitoring the work.
6. Furnish the certified copy of Contractor Registration, of the tender participant and tender winning Firm.
7. Furnish the certified copy of Contractor Enlistment Update reports (Civil), of tender participant and winning Firm.
8. Furnish the certified Affidavit copy Sworn before a Competent Magistrate to the effect that he/she (tender participant), does not have 2 (Two) or more incomplete ongoing commitment (projects/contract to execute) at the time of bidding by the tender participant and winning firm. (as per Arunachal Pradesh Gazette Notification no. SPWD/W-66/2012 Dtd. 01-08-2018 and as per District Based Entrepreneurship Act, 2015 & 2020).
9. Furnish the certified documents submitted by tender participant and winning firm, i.e. copy of completed Three similar work each of value not less than 40% of the estimate cost or Completed Two Similar work each of value not less than 60% of the estimated cost or Completed One similar work of value not less than 80% of the estimated cost along with the Completion Certificate issued by the Engineer in Charge duly Countersigned by the Concerned Superintending Engineer and Chief Engineer, in the last 5 years ending last day of the month previous to the one in which the tenders are invited.
10. Furnish the certified copy of all Photograph of work items (Glossy paper) before starting of work and Photograph (Glossy Paper) after completion of work.

11. Furnish the certified Payment Details (Cheque no., voucher, PFMS etc. (Which ever method is used of payments)) of the project till date.
12. Furnish the certified Solvency certificate certified by the Bankers, submitted by all the tender participant.
13. Furnish the certified Credit facility from Bankers (10% of the tender value) submitted by the tender participants.

In the third hearing held today on 04.06.2026 the Appellant absent without reporting the reason for his absence.

The PIO-cum-EE, RWD, Namsai Division, Namsai District, Govt. of Arunachal Pradesh is present through online mode during the hearing before the Commission.

After going through the Form-A application, the Commission hereby observes;

- i) The Appellant absent continuously for the 2nd time that too without reporting the reason for his absence, which is contempt of this Commission, in fact the Appellant has been repeatedly informed in advance for the hearing.
- ii) The PIO is present through online mode and stated that the information as applied by the Appellant are ready at the office to be furnished to the Appellant but despite reminder, the Appellant has not come to collect the information from the office of the PIO.
- iii) In the absence of the Appellant the Commission relying on the record and by the statement of the PIO during the hearing to the effect that information as applied by the Appellant are ready to be furnished to the Appellant but repeated reminder the Appellant has not turned-up to collect the information, is of the opinion that the Appellant is not interested to collect the information.

Considering the statement of the PIO and viewing seriously the repeated absence of the Appellant and taking cognizance of the absence of the Appellant without any letter of absence, this Commission hereby dispose of this appeal and close it once for all.

Under the above observation and circumstances the Commission, find this appeal fit to be disposed and closed. And accordingly this appeal stands disposed of and closed.
