Information sought :

The appellant file a RTI Application dated 10/09/2025 seeking Details regarding PAA Election 2019 to 2025 and 2025-2029.

As per the case record, PIO had furnished all the sought information.

Being dissatisfied, the appellants filed First Appeal dated 13/10/2025. No hearing was conducted by the First Appellate Authority in his jurisdiction. Feeling aggrieved and dissatisfied by the order of the FAA, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Tame Tallang & Tadar Rokpo absent
Respondent : PIO, O/o Paralympic Association of Arunachal present.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tame Tallang and Tadar Rokpo on 10.09.2025 filed an RTI application under Form-'A' before the PIO, O/o Paralympic Association of Arunachal, HQ, Nirjuli, Papum Pare District, Govt. of Arunachal Pradesh whereby,

seeking various information, as quoted in Form-A application. The Appellants, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **13.10.2025**, Appellants, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **04.12.2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 883/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for two times i.e on 08/06/2026 and 13/07/2026. In this hearing of the appeal on **13th day of July, 2026**, the PIO, O/o the Paralympic Association of Arunachal present in person but the appellants Shri Tame Tallang and Shri Tadar Rokpo found absent without any intimation to the Commission.

As per the order dated 08/06/2026, the appellants were cautioned that if they are found absent in the next date of hearing, the appeal case will be heard in their absence.

Today the appellants are found absent without any intimation to the Commission in spite of giving sufficient chance to appear before the Commission.

Therefore, the Commission deems fit to dispose of and close this appeal case. The appeal No. APIC-883/A/2025 is disposed of and closed.

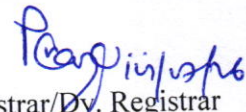
