**JUDGEMENT**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellants Shri Bengia Tani on **20/11/2023** filed an RTI application under Form-'A' before the PIO-Cum- EE, (PWD) Sangram Division, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellants, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **17/01/2024**, the Appellants again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **0/05/2024** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No-203//2024(Appeal)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for hearing on **16/9/2025/ 13/01/2026 & 14/04/2026.**

In the 3<sup>rd</sup> hearing, the Appellants absent consecutively for the 2<sup>nd</sup> time without reporting the reason for their absence despite notice for today's hearing served unto them on **13/01/2026,**

with strict order to be present today in the hearing without fail, failing which this appeal will be heard and **determined ex-parte**.

**In the absence of both the parties the Commission hereby observes;**

- i) The appeal was disposed of on 5/06/2025 with an order for furnishing the information to the Appellants within a period of one month from the date of the receipt of the order.
- ii) The PIO was penalized to pay **Rs 25,000/- (Rupees twenty five thousand)** only for violation of section 7(1) of RTI Act 2005, for which the PIO has deposited the penalty amount as ordered by the Commission.
- iii) This hearing was renewed in the court of the Arunachal Pradesh Information Commission (APIC) as prayed by the Appellants for not receiving of the information, even after the order by the Commission within the time frame set by the Commission.
- iv) In the process of re-hearing on the 2<sup>nd</sup> hearing held on 13/01/2026, the Appellants were absent without reporting the reason for their absence to the Commission.

In the 3<sup>rd</sup> hearing held today in the re-hearing of this appeal the Appellants are consecutively absent for the 2<sup>nd</sup> time without reporting the reason for their absence, despite strict order from the Commission to the Appellants to be present in the hearing without fail.

**After the above observations, the Commission hereby decide;**

The Consecutive absence of the Appellants exhibit their non-seriousness in their appeal and non sincerity in reporting their reason for not being able to attend the court hearing before the Commission, under such non-seriousness of the Appellants filing the 2<sup>nd</sup> appeal before the Commission, makes this Commission decide to dispose of such appeal where Appellants are not serious as well as not interested to pursue the hearing of the appeal, and therefore, the Commission hereby dispose of this appeal and close it once for all.

In view of the above, facts and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed of and closed once for all.
