Information sought :

The appellant file a RTI Application dated 10/09/2025 seeking Details regarding NIT publication for Tender against the Project under PHE & WS Department in Namsai.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellants filed First Appeal dated 23/06/2025. First Appellate Authority had conducted hearing in his jurisdiction on 14/07/2025. Feeling aggrieved and dissatisfied by the order of the FAA, appellant approached the Commission with instant Second Appeal.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Chow Ananta Chowheing on 24/03/2025 filed an RTI application under Form-'A' before the PIO-cum-EE(PHE&WS), Namsai Division, Namsai District, Govt. of Arunachal Pradesh whereby, seeking various information, as

quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **23/06/2025**, Appellants, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **20/11/2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 861/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for two times i.e on 03/06/2026 and 13/07/2026. In this hearing of the appeal on **13th day of July, 2026**, both the parties PIO-cum-EE(PHE & WS), Namsai Division and the appellants Chow Ananta Chowheing attended the hearing through VC.

As per the statement of the appellant, the remaining information sought has been furnished but only National News Paper has not been provided.

PIO stated that the remaining information has been furnished to the appellant, NIT published in local News Paper but it was not published in the national News Paper, so could not be furnished National News Paper.

It is seen that the appellant has been furnished all the information, therefore, the Commission deems fit to dispose of this appeal case. The appeal case No. APIC-861/A/2025 is disposed of and closed.
