ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Wangnon Wangnow, Forest Colony Longding, District Longding, Arunachal Pradesh, for non-furnishing of information by Shri R.W. Zimik, the PIO-cum-EE/ DPIU-II (PMGSY), Rural Works Department, Longding, Longding District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 05/02/2025 regarding Road from 1.54 km point of BRTF Konnu to PMGSY Road to Khonsa.
- 2). The 7th hearing was held on 15th Sept' 2026 (Tuesday) at 1100 hrs. Shri R.W. Zimik, the PIO-Cum-EE/ DPIU-II (PMGSY), Rural Works Department, Longding, Longding District, Arunachal Pradesh was present. The Appellant Shri Wangnon Wangnow appeared before the Court through video conferencing.
- 3). The Appellant informed the Commission that PIO had not yet furnished the authority letter for extended timelines of the PMGSY 3 project till March 2027.
- 4). In reply to the Appellant, the PIO produced the copy of Cabinet briefing notes which was prepared on 18th April' 2026 (Saturday) and the same was handed over to the Commission for perusal.
- 4). The Commission went through the notes and found that the Cabinet had in deed approved continuation of PMGSY 3 with extended timelines : (1) Plain areas March 2028 for roads and bridges (2) Hilly areas March 2028 for roads and March 2029 for bridges.
- 5). Based on the Cabinet brief report and its authenticity, it was found fit to close the case.

Therefore, the case is disposed of and closed.
