**Information sought :**

The appellant file a RTI Application dated 10/06/2025 seeking Details regarding documents pertaining Tender Notice on 05/12/2023 etc.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellants filed First Appeal dated 15/07/2025. The First Appellate Authority was conducted hearing in his jurisdiction on 20/08/2025. Feeling aggrieved and dissatisfied by the order of the FAA, appellant approached the Commission with instant Second Appeal.

**JUDGEMENT ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Nabam Nanu on **10/06/2025** filed an RTI application under Form-'A' before the PIO-cum-EE (RWD), Sagalee Division, Papum Pare District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed

the First Appeal before the First Appellate Authority on **15/07/2025**, Appellants, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **17/09/2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 706/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for five times i.e on 11/02/2026, 08/04/2026, 25/05/2026, 15/07/2025 and 07/09/2026. In this hearing of the appeal on **7<sup>th</sup> day of September, 2026**, both the parties PIO-cum-Executive Engineer (RWD), Sagalee present through VC and the appellant Shri Nabam Nanu present in person.

The PIO has stated before the Commission that all the sought information has been furnished to the appellant through postal address on 10/08/2026. Copy of the forwarding letter is submitted to the Commission. The appellant has stated before the Commission that he has received the information. After going through the information provided, it is seen that all the required information has been furnished.

Commission deems fit to be disposed of the appeal case No. **APIC-706/A/2026**. Accordingly, the appeal case is disposed of and closed.
