Information sought :

The appellant file a RTI Application dated 21/02/2025 seeking Details regarding College admission fees structure of BA, B.Com & B. Sc. etc.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellants filed First Appeal dated 23/05/2025. First Appellate Authority had conducted hearing in his jurisdiction on 13/06/2025. Feeling aggrieved and dissatisfied by the order of the FAA, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Gollo Taker absent.
Respondent : PIO, O/o Principal, Govt. College, Doimukh absent.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Gollo Taker on 21/02/2025 filed an RTI application under Form-'A' before the PIO, O/o the Principal, Govt. College, Doimukh, Papum Pare District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 23/05/2025. Appellants, again

having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **12/11/2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 842/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for two times i.e on 01/06/2026 and 15/07/2026. In this hearing of the appeal on **15th day of July, 2026**, both the parties PIO, O/o the Principal Govt. College, Doimukh and the appellants Shri Gollo Taker found absent without any intimation.

As per the case record, on 01/06/2026, the PIO had made a representation stating that the appellant has repeatedly sought information on the same matter by slightly altering the request of information.

So information sought was not considered necessary by PIO to reply to this present RTI application on the same information.

PIO also referred to CIC's decision in Vijay Prakesh Vs CPIO-cum-Income Tax Officer, Bangalore. Shri Ramesh Chand Jain Vs Delhi Transport Corporation. In which the Hon'ble CIC decided that there is no scope of repetition under RTI Act. Citizen has no right to repeat. Repetition shall be ground of refusal. Appeal can be rejected.

Appellant was directed to present in person before the Commission and reply to the representation made by the PIO and to defend his appeal case that why it should not be rejected on the ground for repeatedly seeking same information from same institution.

But today the appellant is found absent without any intimation to the Commission nor any representation defending his position in this appeal case.

Therefore, the Commission deems fit to dispose of and closed this appeal case on the ground as stated. The appeal case No. APIC-842/A/2025 is disposed of and closed.
