Information sought :

The appellant file an RTI Application dated 13/06/2025 seeking Details regarding - the total numbers of ongoing projects work and completed project works of under the CD Block mengio, Budget under the 15th Finance Commission (FC-XV) FY-2020 to till date sought by him vide his RTI application dated 13/06/2025.

As per the case record, PIO did not furnish the information sought.

Being dissatisfied, the appellant filed First Appeal dated 16/07/2025. No hearing was conducted by the First Appellate Authority in his jurisdiction. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

JUDGEMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Nabam Nanu 13/06/2025 filed an RTI application under Form-'A' before the PIO-cum-District Panchayat Development Officer (DPDO), Yupia, Papum Pare District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-'A' application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **16/07/2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **13/11/2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 844/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 1st time i.e on 1/06/2026. In this hearing of the appeal on 1st day of June, 2026, Both parties, the PIO-cum-District Panchayat Development Officer (DPDO), Yupia, Papum Pare District and the appellant Shri Nabam Nanu present.

As per the order on 1st hearing dated 1/06/2026, the PIO had handed over all the information to the Appellant before the Commission.

The Appellant was directed to submit a written response within 2(two) days after going through the information provided. The Appellant was cautioned that if no intimation is made, the Commission will presume that the Appellant is satisfied with the information provided, and the appeal case will be disposed of and closed.

But till date, no any intimation has been received from the Appellant regarding the information provided to him, if he is satisfied or not . Sufficient time has already been given to the Appellant to submit his dissatisfaction if any from the information provided to him. Therefore, the Commission presumes that the Appellant is satisfied with the information provided to him and accordingly this appeal case No. APIC-844/A/2025 is disposed of and closed.

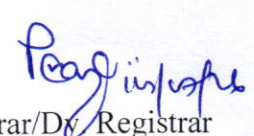
