Information sought:

The appellant filed an RTI application dated 05.09.2025 seeking following information regarding "total amount of fund allocation for Ganga Lake for construction – (1) Welcome Gate (2) Renovation of parking lot (3) PCCF Poma Camp office building from 2023-2025".

Details of information required:

1. Please furnish/provide certified copy the guidelines for Implementation of plan/non-Fund from government of Arunachal Pradesh/ India.
2. Please furnish/provide certified copy the how many amounts of the fund so far received by DFO social forestry Itanagar Division from government of Arunachal Pradesh for development of ganga lake since 2023 to till 2025
3. Please furnish/provide certified copy of the DPR/Sanctioned order copy/Administrative Approval copy.
4. Furnish the certified copy of the non-tendering works order issue against aforesaid works/project if any?

5. Please furnish/provide certified copy of the official order inviting the firms/contractors for attending/participation of the tender process/called e-tender and also furnish copy of local/newspaper published aforesaid NIT.
6. Please furnish/provide certified copy of how many firms were qualified for technical bid and also how many firms has been recommended for price bid to set screening or scrutiny along with showing rate quoted by various firms.
7. Please furnish/provide certified copy of the Board proceeding for selection/acceptance bidders in connection with aforesaid contract work and other letter of correspondences
8. Please furnish/provide certified copy of the Board proceeding for selection/acceptance bidders in connection with aforesaid contract work and other letter of correspondences.
9. Please furnish/provide certified copy of the bill of quantity (BOQ) along with comparative statement of L, 1&L, 2L, 3 bidders.
10. Furnish/provide certified copy of the made correspondences to the successful bidder Le. (1) Formal letter of Acceptance(ii) Agreement made between contractor and public forest department(iii) Issue of notice proceed with work(iv) Performance guarantee/Bank guarantee submitted by the contractors to forest department.
11. Please furnish/provide certified copy of the successful bidder bid documents (i) Contractor's registration/enlistment copy (ii) Trading license, (ii)ST Certificate (iv) PRC Certificate (v)GST registration with latest return filling copy Contractor (vi) Pan card (Vii) Voter I.D (viii) Aadhar card (ix) ITR return filling copy (x) EPF registration with Latest return filling copy
12. Please furnish/provide certified copy of the work completion report copy along with photograph submitted by concern competent authority against aforementioned work details.
13. Please furnish/provide certified copy of the how many amounts has been made payment so far against different heads of the works completed details.
14. Please furnish/provide certified true copy of counter foil/challan/cheque issued and cheque number /PMFS Generated print payment Advise copy in respect of above-mentioned works/firm.
15. Please furnish/provide certified copy of the monitoring team report copy submitted against cited project along with copy of CD/Videography which was done by the monitoring team against the various components of work completed by the contractor/agency.
16. Furnished the fund utilization certificate along with audit report copy.
17. furnish the copy of Geo tag, 1 &Geo tag, 2 photo copy.
18. Furnish the status report copy of the aforementioned works.

Relevant facts emerged during hearing:

Previous Hearing:

1st : 17.04.2026

Order of the 1st hearing- *"The Commission observed that the FAA has heard the appeal and disposed of the appeal case on 11.11.2025 with liberty to the appellant to prefer any appeal before the next Higher Appellate Authority, if he is not satisfied with the information furnished by the PIO. Whereas, the PIO has already replied the item wise RTI query on 23.10.2025. The appellant is directed to specify his dissatisfaction / shortfall in the information and file a written submission to the PIO within one week from the date of issue of this order. The PIO is directed*

to furnish any additional information / clarification within two weeks from the date of issue of this order. The appellant shall submit a status report of the additional information / clarification received from the PIO within three weeks from the date of issue of this order."

The following were present.

Appellant : Present. He states that he has served a legal notice under section 80 of the Civil Procedure Code, 1908 and intimated to this commission in writing.

Respondent PIO : Representative of the PIO Ld. Counsel Adv. Taring Takap appeared. He states that information sought under serial number 1 and 3 in RTI application is not available with the PIO. The pertaining scheme was not implemented under Social Forestry Division, Itanagar. The appellant was advised to approach office of the Deputy Chief Wild Life Warden, Naharlagun. The information pertaining to serial number 2 has already been furnished to the appellant.

Decision:

The Commission after adverting to the facts and circumstances of the case, perusal of the records and hearing the parties, observes that the PIO has already furnished the information available with the PIO pertaining to 2) Renovation of Parking Lot to the appellant. The information under serial number 1 and 3 is not implemented under PIO – Social Forestry Division, and the representative of the PIO has advised the appellant to approach the office of the Deputy Chief Wild Life Warden, Naharlagun for the same. The appellant has not filed any written specific shortfall in the information under serial number 2 to this commission as ordered by this commission in its interim order dated 17.4.2026. Instead he has informed to this commission about his legal notice served to the PIO under Section 80 of The Civil Procedure Code 1908. The appellant has agreed to close this appeal case under RTI Act.

The appeal case is disposed of accordingly at this commission.
