Information sought :

The appellant file an RTI Application dated 06/06/2025 seeking Details regarding – Arunachal Frontier Highway Viz LADA to Sarli. 2. Sarli to Huri. 3. Huri to Taliha in the District.

As per the case record, PIO did not furnish the information sought.

Being dissatisfied, the appellant filed First Appeal dated 04/07/2025. No hearing was conducted by the First Appellate Authority in his jurisdiction. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Bengia Papo absent.
Respondent : PIO-cum-DLRSO, Koloriang, Kurung Kumey District absent.

JUDGEMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Bengia Papo 06/06/2025 filed an RTI application under Form-'A' before the PIO-cum- DLRSO, Koloriang, Kurung Kumey District Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-'A' application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **04/07/2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **03/10/2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 741/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 1st time i.e on 22/04/2026 and 22/07/2026. In this hearing of the appeal on 22nd day of July, 2026, Both the parties, PIO-cum- DLRSO, Koloriang, Kurung Kumey District and the appellant Bengia Papo absent without any intimation to the Commission.

On the last hearing dated 22nd April, 2026 the appellant was cautioned that if he is found absent the case will be heard in his absence. Today, the appellant is absent without any intimation to the Commission in spite of giving summon notice through his personal number as well as postal address. The Commission presumes that the appellant has no more interest to pursue the appeal case. Accordingly this appeal case No. APIC-741/A/2025 is disposed of and closed.
