Information sought:

The appellant has filed an RTI application dated 10.02.2025 seeking following information regarding MGNREGA under Hayuliang-Goilang CD Block.

Details of information required:

- Certified copy of Notice Inviting Tender (NIT) of Material procurement under your CD Block from 2020 to till date.
- Certified copy of New Papers cuttings of NIT published in State/Local Newspapers from 2020 to till date.
- Certified copy of all the Board Members of tender processing from 2020 to till date.
- Certified copy of the Firm/Vendor/Supplier who won the tender and did the work from 2020 to till date.

- (e) Certified copy of payment done to Firm/Vendor/Supplier i.e. cheque leafs/DD/PFMS/Cash/RTGS in details.
- (f) Certified copy of material procurement/bill year wise in details from 2020 to till date.
- (g) Certified copy of all the firms/vendor who participated and submitted the bids: 1. Technical Bids 2. Financial Bids.
- (h) Certified copy of firms qualified in technical bid and participated in the technical and financial bid along with comparative statement.
- (i) Certified copy of GST Reg No. Income-Tax Clearance Certificate, Latest Audit report of last 3 (Three) years duly certified/ Audited by the Chartered Accountant of the firm, Bank Solvency Certificate, Firm Registration Certificate of the Firm/Vendor/Supplier who did the work year wise.
- (j) Certified copy of name of all BDO, EO who executed/implemented the said work/schemes from 2020 to till date.
- (k) Certified copy of Geo-Tag, Geo-Coordinate, Photographs, Videography of the work Panchayat wise from 2020 to till date.
- (l) Certified copy of cashbook statement with page numbers or give hand receipt with payee name of the said work.
- (m) Certified copy of bill of the said work.
- (n) Certified copy of affidavit of having not more than 2(Two) works in hand under the State Govt. by the Firm.

Other Details -Inspection of work, Document and records under section 2(j) of RTI Act, 2005 to be assisted by BDO/EO of the said work/scheme/project.

Period for which information asked for: -2020 to till date

The following were present.

Appellant : Present through VC. He states that he has received the information at serial number j) to n) but the PIO has advised him to approach office of the Deputy Director (RD), Hawai, Anjaw District, AP for rest of the information for serial (a) to (i).

Respondent PIO : Absent. Shri Bashai Pul, Accountant represented the PIO through VC. He states that all available information has already been furnished to the appellant.

Decision:

The commission after adverting to the facts and circumstances of the case, perusal of the records and hearing the parties, observes that the FAA has conducted hearing on 22.09.2025 and passed judgement for furnishing the available information to the appellant free of cost. In today's hearing the appellant submits that he has already received the information sought at serial j) to n) in RTI application. The PIO has advised the applicant in writing dated 18.9.2025 to seek the remaining information from the Deputy Director (RD), Hawai, Anjaw District.

As per Office Memorandum No.AR-152/2010/228 dated 1th November 2020, AR Department Govt. of Arunachal Pradesh for implementation of Office Memorandum

No.F.10/2/2008-IR Ministry of Personnel, PG and Pensions, Department of Personnel & Training, New Delhi, "if a person makes an application to the public authority for information, a part of which is available with that public authority and the rest of the information is scattered with more than one other public authorities, the Public Information Officer (PIO) of the public authority receiving the application should give information relating to it and advise the applicant to make separate applications to the concerned public authorities for obtaining information from them. It further provides that if no part of the information is available with the public authority receiving the application but scattered with more than one other public authorities, the PIO should inform the applicant that information is not available with the public authority and that the applicant should make separate application to the concerned public authorities for obtaining information from them. The matter has been examined in consultation with the Chief Information Commissioner, Central Information Commission and it has been decided to advise the PIOs that if the details of public authorities who may have this information sought by the applicant are available with the PIO, such details may also be provided to the applicant."

Accordingly, the appellant may file a fresh application to the PIO office of the Deputy Director (RD), Hawai, Anjaw District for the remaining information at serial (a) to (i) of his RTI application. Now, the commission found this appeal against PIO-BDO Hayuliang is fit case for closure.

The appeal case is disposed of accordingly at this commission.

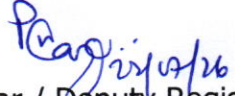
