JUDGMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI, Act, 2005. Brief fact of the case is that the Appellant, Shri Ratan Chetia on **29/08/2025** filed an RTI application in form 'A' before the PIO-cum-Block Development Officer (BDO), Namsai, Namsai District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' application. The Appellant being not receiving the information from the PIO filed the First Appeal before the First Appellate Authority (FAA) on **15/10/2025**. Appellant again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **18/03/2026** and the Registry of the Commission (APIC) having receipt of the Appeal registered it as APIC- No. **335/A/2026** (Appeal) and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on **02.07.2026 & 10.09.2026**.

In the second hearing held today on **10.09.2026** both the parties are present through online mode during the hearing before the Commission.

Heard the Appellant;

The Appellant stated that as per the order of the Arunachal Pradesh Information Commission (APIC) in the last hearing held on 2nd day of July' 2026, the PIO was ordered to provide the information pertaining to Serial No. M of the Form-A, and I have received the information from the PIO.

Heard the PIO;

The PIO stated that whatever information pertaining to S/No. M of the Form-A of the Appellant I have provided the information and obtained the receipt copy of the Appellant.

After hearing both the parties the Commission hereby observes;

- i) The PIO has carried out the order of the Commission and provided the required information to the Appellant to which the Appellant also submitted and accepted that the PIO has provided to him the information and the court of the Commission may dispose of this matter today.

Under the above observations and circumstances the Commission, find this appeal fit to be disposed and closed. And accordingly this appeal stands disposed of and closed once for all.
