Information sought :

The appellant file a RTI Application dated 12/08/2025 seeking Details regarding Appointment Order, Promotion order copies and all other related documents in respect of Shri Sanjay Bengia, Dy. Director (TE).

As per the case record, PIO had furnished all the sought information.

Being dissatisfied, the appellant filed First Appeal dated 30/09/2025. First Appellate Authority had conducted hearing in his jurisdiction on 14/11/2025. Feeling aggrieved and dissatisfied by the order of the FAA, appellant approached the Commission with instant Second Appeal.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tai Shiva, Ngaker Jumken, Kaling Tabi & Mangming on **12.08.2025** filed an RTI application under Form-'A' before the PIO-cum-Dy. Director, Higher & Technical Education, Itanagar, Papum Pare District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellants, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **30.09.2025**, Appellants, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **02.12.2025** and the

Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 879/A/2025**, and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for two times i.e on 08/06/2026 and 13/07/2026. In this hearing of the appeal on **13th day of July, 2026**, PIO-cum-Dy. Director Hr. & Technical Education is represented by Shri Nitin Kumar Tripathi, APIO but the appellants Shri Tai Shiva, Ngaker Jumken, Kaling Tabi & Mangming found absent without any intimation.

As per the case record all the information have been provided which is available with the authority. Sought information at Sl. No. 2 is related to service details of the individual which is protected under Section -8(1) (e) and Section-8 (1) (j) under RTI Act.

Section-8 (1) (e): Information available to a person in the fiduciary relationship, unless the competent authority is satisfied that the larger public interest warrants the disclosures of such information.

Section-8 (1) (j) : Information which relates to a personal information the disclosures of which has no relationship to any public activity or interest or which would cause unwarranted invasion of the privacy of the individual unless the Central Public Information Officer or the State Public Information Officer or the appellate authority, as the case may be, is satisfied that the larger public interest justifies the disclosures of such information.

The appellants have not justified any larger public interest. Moreover, the appellants are absent for the last 2 time consecutively without any intimation. The appellants were cautioned during the last hearing dated 08/06/2026 that if they are found absent in the next date of hearing, the case will be decided in their absence. Today, the appellants are absent without any intimation to the Commission.

Therefore, on the grounds as stated the Commission deems fit to dispose of and close this case. The appeal case No. APIC-879/A/2025 is accordingly disposed of and closed.
