JUDGMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Chow Lajamang Mannow on **07/08/2025**, filed an RTI application under Form-'A' before the PIO-Cum-EE, Department of (PWD), Jairampur Division, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **24/09/2025** the Appellant, again having not received therequired information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **13/11/2025** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No. 858/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission two times on **07/05/2026 & 21/07/2026, respectively.**

In the 2nd hearing held on **21st July'2026**, related to the **APIC No-858/A/2025**. The Appellant Chow Lajamang Mannow, present during the hearing through online mode.

The PIO-cum- EE (PWD) Jairampur Division, District Changlang , Govt of Arunachal Pradesh, absent during the hearing without reporting the reason for his absence to the Commission, whereas he was present in the 1st hearing which was held on **7/5/2026**.
