Information sought:

The appellant filed an RTI application dated 06.03.2025 seeking following information regarding JJM scheme of Innao Khamti, Mudoi Innao Pathar, Dumba Singpho villages.

Details of the Information required-

- Certified copy of sanction memo and AA & ES of all the said works/schemes.
- Certified copy of NIT, newspaper cuttings of NIT published in e local/state newspapers.
- Certified copy of Letter of Award (LoA) and agreement between EE and firm proprietor or power of attorney.
- Certified copy of name of the firms who participated in technical and financial bids and who won the tender.
- Certified copy name of the board members of the tender proceedings and comparative statements.
- Certified copy of measurement book of the all said work/scheme.

- g. Certified copy of payment details paid to the firms, RTGS/NEFT/demand draft/cheque leaf etc.
- h. Certified copy of cash book statements with page numbers and give hand receipt with payee name of all the said works.
- i. Certified copy of completion certificate and utilization certificate of all the above mention work/schemes.
- j. Certified copy of first and final bill of all the said works/schemes.
- k. Certified copy of name of EE/AE/JE who executed the said works or schemes.

Relevant facts emerged during hearing:

Previous Hearing:

1st	:	09.02.2026
2nd	:	10.04.2026

Order of the 2nd hearing- *"The Commission observed that the First Appellate Authority has passed an order on 9.6.2025 in which he has directed PIO to furnish the requisite information. Irrespective of FAA's order and this commission's order dated 9.2.2026 the PIO has not furnished the information. The PIO is found absent in today's hearing consecutively for second time. He is hereby warned for non-compliance of order of the FAA, this Commission's order and for remaining absent during hearing. The PIO is directed to furnish the information to the appellant within two weeks from the date of issue of this order. The appellant shall serve a copy of this order to the PIO and obtain acknowledgement receipt. A copy of receipt so obtained shall be submitted to this commission by the appellant."*

The following were present.

Appellant : Present through VC. He states that the PIO has not furnished any information in spite of order passed by the FAA and the Commission.

Respondent PIO : Present through VC. He states in response to previous order of the Commission, he has written to the appellant on 15.05.2026 for deposit of fee of Rs 11,002/- but no response from the appellant.

On interjection the appellant states that the said letter dated 15.5.2026 is not received by him. He sought to receive the information free of cost as the stipulated time for payment of document fee has already expired. A copy of the said letter from the PIO is received by the appellant today.

Decision:

The Commission after adverting to the facts and circumstances of the case, and perusal of the records, hearing the parties observes that PIO has delayed in communication with the appellant beyond stipulated time period to realise the fee for furnishing information. The PIO shall furnish the information document free of cost.

The PIO is directed to furnish the information to the appellant within one week from the date of issue of this order. The appellant shall serve a copy of this order to the PIO and obtain the information document. He shall file a written status of information received by him to this commission within one week from the date of receipt of the information.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. In case no compliance report is received at commission from the PIO and appellant within stipulated time, this appeal case shall stand closed.

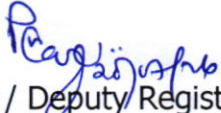
