The appellant file an RTI Application dated 05/04/2025 seeking Details regarding –  
Establishment of Broiler poultry farm at Yachuli, Lower Subansiri District, A.P

Being dissatisfied, the appellant filed First Appeal dated 05/05/2025. No hearing  
was conducted by the First Appellate Authority in his jurisdiction. Feeling aggrieved and  
dissatisfied, appellant approached the Commission with instant Second Appeal.

## JUDGEMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Miss Bengia Mama 03/04/2025 filed an RTI application under Form-'A' before the PIO-cum- EE/JE, Engineering Wing, Dept. of Education, C/o DDSE, Likbali, Lower Siang Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-'A' application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **05/05/2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **18/06/2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 496/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 1st time i.e on 22/04/2026 and 22 July, 2026. In this hearing of the appeal on 22nd day of July, 2026, The PIO-cum-EE/JE, Engineering Wing, Dept. of Education, C/o DDSE, Likabali, Lower Siang District found absent and the appellant Bengia Mama present.

The appellant stated that the documents pertaining to the appeal case has already been provided to her and the appellant requested to close the appeal case. The Commission accepted the request and accordingly this appeal case No. APIC-496/A/2025 is disposed of and closed.
