Information sought :

The appellant file a RTI Application dated 11/07/2025 seeking Details regarding furnishing all the related documents of the non-regular staff of the department and list of the said staff.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 10/09/2025. No hearing was conducted by the First Appellate Authority in his jurisdiction. Feeling aggrieved and dissatisfied by the order of the FAA, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Dawa absent
Respondent : PIO-cum- SE(Coord), RWD, Itanagar absent.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Dawa Tsering on **11.07.2025** filed an RTI application under Form-'A' before the PIO-cum-Superintendent Engineer (Coord), RWD, Itanagar, Papum Pare, District, Govt. of Arunachal Pradesh whereby, seeking various

information, as quoted in Form-A application. The Appellants, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **12.09.2025**, Appellants, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **24.10.2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 802/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for two times i.e on 20/04/2026 and 20/07/2026. In this hearing of the appeal on **20th day of July, 2026**, Both the parties the PIO-cum-Superintendent Engineer (Coord), RWD, Itanagar and the appellants Shri Dawa Tsering found absent without any intimation.

Appellant was directed on the last hearing dated 20/04/2026 to appeal before the Commission and it was cautioned that if found absent in the next hearing, his appeal case will be heard in his absence. Today both the parties found absent without any intimation.

The Commission presumes that appellant is no more interested to pursue this appeal case. The appellant is consecutively absent for consecutively 2 hearings, therefore, this appeal case is disposed of and closed.
