Information sought :

The appellant file a RTI Application dated 21/02/2025 seeking Details regarding documents related to Grade D- staff working under DDSE, Daporijo, Upper Subansiri District.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellants filed First Appeal dated 23/05/2025. No hearing was conducted by the First Appellate in his jurisdiction. Feeling aggrieved and dissatisfied by the order of the FAA, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Tajum Dadi present.
Respondent : PIO-cum-DDSE, Daporijo present.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tajum Dadi on 27/0/2025 filed an RTI application under Form-'A' before the PIO-cum-DDSE, Daporijo, Upper Subansiri District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 09/06/2025, Appellants, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 08/10/2025 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 761/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for two times i.e on 22/04/2026 and 22/07/2026. In this hearing of the appeal on 22nd day of July, 2026, both the parties PIO-cum-DDSE, Daporijo, Upper Subansiri and the appellants Shri Tajum Dadi present in person.

Today appellant intimated that he has received all the information and requested to dispose the case.

Request accepted and the appeal case No. APIC-761/A/2026 is disposed of and closed.

Judgment/Order pronounced in the open Court of this Commission today on this 22nd day of July, 2026. Each copy of Judgment/Order be furnished to the parties.

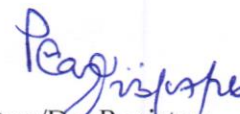
