Information sought :

The appellant file an RTI Application dated 17/08/2023 seeking Details regarding C/o CC Pavement from main town to Donyi Polo Colony under RE Scheme Palin, Kra Daddi District..

As per the case record, PIO has never conducted hearing under his jurisdiction.

Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal on 22/09/2023.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tam Rararu on **17.08.2023** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (PWD), Palin Division, Kra Daddi District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the Second Appeal before the Arunachal Pradesh Information Commission on **22.09.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 928/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 11 times i.e on 02/12/2024, 13/01/2025, 24/02/2025, 26/03/2025, 28/04/2025, 10/11/2025, 19/01/2026, 06/04/2026, 25/05/2026 and 15/07/2026. In this hearing of the appeal on 15th day of July, 2026, the PIO-cum-Executive Engineer (PWD), Palin Division present through VC and the appellant Shri Tam Rararu present in person.

As per the order dated 25/05/2026, the appellant was directed to verify the documents which are not visible which is in the office of the SE (PWD), Palin where the original documents are available. The appellant was also directed to intimate to the Commission after verification of the document.

Today appellant is present and stated that he has verified original documents as per the direction of the Commission and he is satisfied.

Therefore, the appeal case is disposed of and closed.

Judgment/Order pronounced in the open Court by the Commission today on this **15th day of July, 2026**. Each copy of Judgment/Order be furnished to the parties.

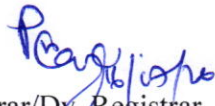
