**JUDGEMENT**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Dawa Tsering on **03/01/2024** filed an RTI application under Form-'A' before the PIO-Cum-Divisional Forest Office (DFO) West Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **05/03/2024**, the Appellant again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **30/04/2024** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No-191/2024(Appeal)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for hearing on **18/04/2024, 30/07/2024, 03/09/2024, 26/11/2024, 24/06/2025 & 09/04/2026.**

**Details of information sought by the Appellants.**

**PART-I (CAMPA)**

1. Furnish Sanction Ondet, copy of Funds received in respect of Bomdila Forest Division, West Kameng Diuriet for implementation of Hems under CA & NVV componerms of the state Mate CAMPA AOP since 2019 to 2023 and till date.
2. Utilisation Certificates of all the works carried out under Sure CAMPA Scheme under Kange Forea Office. Dirang Mango since 2019 in 2023 and ill documents
3. List of us carried out under CA components with amount bifurcation for each words under Dirang Kange along with Geo Coordinates doulk
4. List of works carried out under NPV components with anwnant details under Range Forest Office Dirang Range since 2019 to 2023 and tili slate.
5. Names of contractors whom works awarded for carrying out NPV components.
6. Copy of payments details with cheque details counterfoils details made in respect of Range Forest Officer Dieang Range since 2019 to 2023 to till date.

**PART-11 (land Acquisition for CA & ANR Plantation)**

1. Lat of VERS (Village Forest Reserves under Range Forest Office. Dirang Range
2. Malls (Agreement papers signed with the village cvaimunity and Forest Department for Creation of VERS
3. Mutation certificates of all the VERs and notifications toes by the Govt. of Arunachal

In the 5<sup>th</sup> hearing held on **9<sup>th</sup> April 2026**, related to the **APIC No. 191/A/2024**. The Appellant Shri Dawa Tsering, is absent for the consecutive second time during the hearing without intimating to the Commission the reason for his inability to attend the hearing.

The PIO represented by Shri Gollo Nera, APIO Bomdila Forest Division with an authorization letter from the PIO present during the hearing through online mode.

**Heard the APIO.**

The APIO stated that as ordered by the Commission on 8/4/2025, all the information(s) have been completely provided to the Appellant.

After hearing the APIO and taking the serious note of the consecutive absence of the Appellant in the hearings without reason being assigned to the Commission;

**The Commission hereby orders;**

- i) The Appellant was ordered to be present today by serving the notice of hearing wherein it was clearly stated that in the repeated absence of the Appellant, the Commission will presume that the PIO has provided to him the complete information and **this appeal will be heard and determined ex-parte.**
- ii) Consequent upon the previous order of the Commission and issue of notice for hearing the absence of the Appellant consecutively in the hearing, makes this Commission believe that the Appellant is not serious on his appeal and has received the complete information from the PIO. Therefore, this appeal is disposed of.

In view of the above, findings and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed of and closed once for all.
