Information sought :

The appellant file a RTI Application dated 22/08/2025 seeking Details regarding Contractor enlistment and Revalidation of M/s Puna Hinda Or M/s Taso Hinda from the year 2008 to till date.

As per the case record, PIO had furnished all the sought information.

Being dissatisfied, the appellant filed First Appeal dated 12/09/2025. First Appellate Authority had conducted hearing in his jurisdiction on 23/09/2025. Feeling aggrieved and dissatisfied by the order of the FAA, appellant approached the Commission with instant Second Appeal.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tai Shiva, Ngaker Jumken, Kaling Tabi & Mangming on **22.08.2025** filed an RTI application under Form-'A' before the PIO, O/o Chief Engineer (CSQ), PWD Department, Itanagar, Papum Pare District, Govt. of

Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellants, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **12.09.2025**, Appellants, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **02.12.2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 881/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for two times i.e on 08/06/2026 and 13/07/2026. In this hearing of the appeal on **13th day of July, 2026**, both the parties PIO, O/o the Chief Engineer (CSQ), PWD, Itanagar and the appellants Shri Tai Shiva, Ngaker Jumken, Kaling Tabi & Mangming found absent without any intimation.

As per the order dated 08/06/2026, the appellant was directed to be present before the Commission in the next date of hearing and he was also cautioned that if they are found absent without any intimation to the Commission, the case will be decided in their absence.

Summon notice was sent to the appellants through his personal whatsapp, group whatsapp as well as their postal address.

Today appellants are found absent for the second time without any intimation. Therefore, the Commission deems that the appellants are no more interested to pursue this appeal case inspite of giving sufficient chance to appear before the Commission.

Therefore, the appeal case No. APIC-880/A/2025 is disposed of and closed.
