Information sought :

The appellant file a RTI Application dated 24/03/2025 seeking Details regarding documents pertaining Establishment of Broiler Poultry Farm at Yachuli, Lower Subansiri District, Arunachal Pradesh for the year-2023-24.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellants filed First Appeal dated 15/07/2025. No hearing has been conducted by the First Appellate Authority in his jurisdiction in this regard. Feeling aggrieved and dissatisfied by the order of the FAA, appellant approached the Commission with instant Second Appeal.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Miss Bengia Mama on **24/03/2025** filed an RTI application under Form-'A' before the PIO-cum-EE (PWD), Yazali Division, Keyi Panyor District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed

the First Appeal before the First Appellate Authority on **06/05/2025**, Appellants, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **18/06/2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 495/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for three times i.e on 22/04/2026, 22/07/2026 and 09/09/2026. In this hearing of the appeal on **9th day of September, 2026**, both the parties present. PIO-cum-Executive Engineer (PWD), Yazali Division is represented by Shri Bengia Tebin, PA and the appellant Miss Bengia Mama present in person.

All the sought information has already been provided to appellant by the PIO, and copy of the communication evidencing such furnishing has been placed before the Commission today.

Accordingly, the appeal case is disposed of and the case is closed.
