ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Maji Tayem and Shri James Teli Camdir for non-furnishing of below mentioned information by the PIO, o/o the Additional Deputy Commissioner, Sagalee, Papum Pare District as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 12.01.2026.

A. Particular of information: details information regarding land compensation against ongoing 33k Hydro Power Project from "DakteHoj to SangkumGika"

B. Details of information required:

1. Furnish a detailed compensation/ beneficiary list.
2. Provide details of the total funds sanctioned by the Govt.
3. Furnish details of the fund released to the beneficiaries as compensation.
4. Provide details of payments made through cheque/ DD/ receipt or any other records.
5. Furnish the derailed rates paid to the beneficiaries for land and other properties, i.e. agricultural, horticultural, Govt. and private properties.
6. Provide detailed measurements or total areas of land owned by each beneficiary under the ongoing project.
7. Furnish details copy of the beneficiaries' geo tagging of the land area.
8. Provide the relevant documents of hard copies are not possible, kindly provide them via a pen drive.

C. Period for which information asked for: 2020 to till date.

Brief facts emerging from the appeal and decision thereon:

Records in the appeal reveal that the appellants had requested the PIO for the aforementioned information but failed to obtain the same within the statutory period of one month which prompted them to file appeal before the First Appellate Authority (FAA), the Deputy Commissioner, Papum Pare District, Yupia under section 19(1) of the RTI Act vide their Memo of Appeal dt. 17.02.2026. But having failed yet again to obtain the information, they preferred second appeal before this Commission under section 19(3) of the RTI Act vide Appeal Memo dt. 30.03.2026.

This appeal is, accordingly, listed today on 17.07.2026, wherein one of the appellants, namely Shri Maji Tayem is present in person while Shri Kipa Raja, ADC-cum-PIO and Shri I Perme, A.C-cum-APIO are present through V.C.

Heard the parties.

The PIO and the APIO submitted that the appellants have already been furnished with the part of the requested documents/information and the DLR&SO, Yupia was also advised to furnish some of the requested information/documents to the appellant.

The appellant also acknowledged the receipt of the sought for information in 2(two) phases from the o/o the PIO. The appellant, however, submitted that he did not receive the documents/information against his queries Nos. (g) and (h) OR (7 and & 8). But he did not press for the same as he is satisfied with the replies/information furnished against rest of the queries.

In the premises as above, this appeal does not require any further adjudication in this Commission and resultantly, it stands disposed of and closed.
