**Information sought :**

The appellant filed an RTI Application dated 18/08/2025 seeking Details regarding appointment, service status, transfer/posting and regularization details of Assistant Mineral Development Officers (AMDOs) and Mineral Guards (MGs) in the department of Geology & Mining engaged on the basis of officiating, contractual, contingency, work-charged (W/C), Adhoc and Regular services across the State.

As per the case record, PIO had furnished all the sought information.

Being dissatisfied, the appellant filed First Appeal dated 06/10/2025. No hearing was conducted by the First Appellate Authority in his jurisdiction. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

## JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Kurung Dolo 18/08/2025 filed an RTI application under Form-'A' before the PIO-cum-Dy. Director, Geology & Mining, Itanagar, Papum Pare District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 16/10/2025, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 05/12/2025 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as APIC No. 889/A/2025 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 1<sup>st</sup> time i.e on 10/06/2026. In this hearing of the appeal on 10<sup>th</sup> day of June, 2026, both the parties Appellant Shri Kurung Dolo and the PIO-cum-Dy. Director, Geology & Mining, Itanagar found absent however, a request letter has been received from the appellant to dispose of the appeal case, as he has already received the sought information.

Request accepted and the appeal case No. APIC-889/A/2025 is disposed of and closed.
