Information sought :

The appellant file a RTI Application dated 19/08/2025 seeking Details regarding Appointment/APCS Examination 2008-2010 and promotion of Shri Takam Nicholas, EAC (HQ), Itanagar.

As per the case record, PIO had furnished all the sought information.

Being dissatisfied, the appellant filed First Appeal dated 09/10/2025. First Appellate Authority had conducted hearing in his jurisdiction on 27/10/2025. Feeling aggrieved and dissatisfied by the order of the FAA, appellant approached the Commission with instant Second Appeal.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tai Shiva, Ngaker Jumken, Kaling Tabi & Mangming on 19.08.2025 filed an RTI application under Form-'A' before the PIO-cum-Under Secretary (Personnel), Civil Secretariat, Itanagar, Papum Pare District, Govt. of

Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellants, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **09.10.2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **02.12.2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 881/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for two times i.e on 08/06/2026 and 13/07/2026. In this hearing of the appeal on **13th day of July, 2026**, both the parties PIO-cum-Under Secretary (personnel) and the appellant Shri Tai Shiva, Ngaker Jumken, Kaling Tabi & Mangming found absent without any intimation.

As per the order dated **08/06/2026**, the appellants were directed to mention specific information as per their form 'A' application as the appellants had mentioned in their appeal that PIO had furnished incomplete and misleading information. The appellants were cautioned that if no intimation is made before the PIO seeking his remaining information as per form 'A', the Commission will presume that the appellants are satisfied by the information provided. But till date no intimation has been made by the appellant regarding sought information as well as for their absence.

The appellants are absent for consecutively last 2 (two) occasions. Therefore, the Commission presumes that appellants are no more interested to pursue this appeal case and they are satisfied by the information provided. Therefore, the appeal case No. APIC-881/A/2025 is disposed of and closed.
