Information sought :

The appellant file a RTI Application dated 14/07/2025 seeking Details regarding furnish relevant documents in respect of Contingency staff and adhoc staff in the department and their appointment order.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 15/08/2025. No hearing was conducted by the First Appellate Authority in his jurisdiction. Feeling aggrieved and dissatisfied by the order of the FAA, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Nechang Kamke absent

Respondent : PIO-cum- APB&OCWWB< Itanagar present through VC.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Nechang Kamke on **14.07.2025** filed an RTI application under Form-'A' before the PIO-cum-Arunachal Pradesh Building & Other Construction Workers Welfare Board, Itanagar, Papum Pare, District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellants, being not satisfied with the information received from the PIO, filed the First

Appeal before the First Appellate Authority on **15.08.2025**, Appellants, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **23.10.2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 795/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for two times i.e on 20/04/2026 and 20/07/2026. In this hearing of the appeal on **20th day of July, 2026**, PIO-cum-Arunachal Pradesh Building & Other Construction Workers Welfare Board, Itanagar, present through VC but the appellants Shri Nechang Kamke found absent without any intimation.

As per the case record the appellant was absent on the last hearing dated 20/04/2026 and it was cautioned that if found absent in the next hearing the case will be heard in his absence. Today again the appellant is found absent without any intimation.

The PIO stated that the sought information have already been provided to the appellant.

The appellant is found consecutively absent from the last 2 occasion without any intimation in spite of giving Summon notice.

Therefore, the Commission presumes that the appellant is no more interested to pursue this appeal case and the Commission also presumes that relying upon the statement of the PIO, the information sought has already been provided to the appellant.

Therefore, this appeal case is deemed fit to be disposed of and accordingly, this appeal case is disposed of and closed.

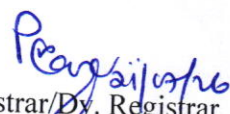
