Information sought :

The appellant file a RTI Application dated 06/05/2025 seeking Details regarding Sanction order copy, technical sanction order copy etc. in respect of C/o Augmentation of water supply system at Namsai Township (7.9).

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellants filed First Appeal dated 12/06/2025. No hearing was conducted by the First Appellate in his jurisdiction. Feeling aggrieved and dissatisfied by the order of the FAA, appellant approached the Commission with instant Second Appeal.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tamchi Gungte on 06/05/2025 filed an RTI application under Form-'A' before the PIO-cum-EE (PHE & WS), Namsai Division, Namsai District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A

application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **12/06/2025**, Appellants, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **04/08/2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 610/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 4 times i.e on 26/11/2025, 18/03/2026, 05/05/2026 and 29/07/2026. In this hearing of the appeal on **29th day of July, 2026**, PIO-cum-EE (PHE & WS), Namsai Division present through VC but the appellants Shri Tamchi Gungte found absent without any intimation.

PIO has stated that the remaining documents which are not visible had already been sent to the appellant through postal address.

On the third hearing dated 06/05/2026, appellant was directed to intimate the Commission after receipt of the remaining document from the PIO and cautioned that appellant be present in the next date of hearing. Today the appellant is found absent for second consecutive times without any intimation.

Therefore, the Commission presumes that the appellant has received all the documents and he has no further interest to pursue this appeal case. Accordingly, this appeal case is disposed of and closed.
