ORDER/SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tanya Ronya and Shri Penter Ronya for non-furnishing of below mentioned information by the PIO, o/o the E.E (PWD), Yomcha Division, West Siang District (A.P) as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 22.04.2025:

Brief facts emerging from the appeal:

Records emerging from the appeal disclose that the Appellants, Shri Tanya Ronya and Shri Penter Ronya had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted them to appeal before the Chief Engineer (PWD), Central Zone-B, Pasighat, East Siang District (A.P) as the First Appellate Authority (F.A.A) under Section 19 (1) of the RTI Act vide their Appeal Memo dated 26.05.2025.

Records further reveal that the FAA conducted hearing on 22.07.2025 and passed the following order :

"ORDER

1. This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tanya Ronya, for non-furnishing of documents by the
2. PIO-Cum- EE (PWD), Yomcha Division as sought by the Appellant under Section 6(1) of RTI Act, 2005 regarding:
 - a. Copy of Cash book of Yomcha, PWD Division wcf 01/04/2024 to 31/03/2025.

3. On receipt of the above appeal, the case was admitted in this court and the First Hearing and Second Hearing of the case were conducted on 24/06/2025 and 09/07/2025 respectively. During the hearings, both the Respondent and the Appellant were absent.
4. The third hearing of the case is conducted today on 22/7/2025. During the hearing both the respondent. PIO and the appellant were present.
5. The court heard the statement of both the respondent PIO and the Appellant and directed the PIO to furnish the documents to the Appellant within 12 days from the date of issue of this order with intimation to this office.

With this, the Case stand disposed off.

The appellants, apparently, failed to obtain the information yet again from the PIO and as such they filed their 2nd appeal before this Commission under section 19(3) of the RTI Act vide their Memo of appeal dt.03.12.2025.

This appeal is, accordingly, listed today on 03.07.2026 but the PIO is absent without any intimation while one of the appellants, namely, Shri Tanya Ronya is present in person.

The non-appearance of the PIO in the hearing has been viewed seriously by this Commission which if repeated next time, this Commission shall be constrained to invoke the penal provisions of the RTI Act, 2005.

The appeal is listed again on 24.07.2026 and in the meantime the PIO is directed to furnish the requested information/documents to the appellants and report compliance thereof on 24.07.2026.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.

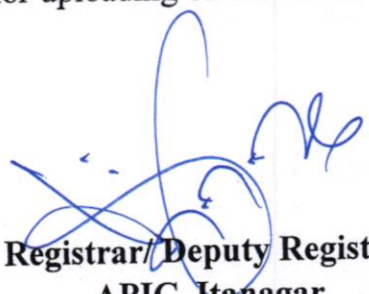
